

- ① The sum of \$55,750.00 to be paid to BTZ on account of the Bridge property.
- ② The sum of \$27,500.00 to be paid to BTZ, ~~and~~ to be allocated between the High Point and Caldwell on a pro rata basis.
- ③ No cross-examinations to occur until after December 19, 2018.
- ④ This Order is without prejudice to BTZ coming back for the release of further funds on or after December 19, 2018.
- ⑤ The funds referred to in paragraphs ① and ② above, are on account of fees and disbursements already incurred by BTZ and for its fees and disbursements to prepare for the motion returnable December 19, 2018.
